- ALL PROJECTS COMPLETED AFTER JANUARY 1, 2020, ARE ELIGIBLE FOR SUBMISSION. PREVIOUS AWARD-WINNING PROJECTS ARE NOT ELIGIBLE.
- ENTRANTS MAY SUBMIT MULTIPLE PROJECTS.
- A PROJECT MAY ONLY BE ENTERED IN A SINGLE CATEGORY.
- EACH COMPANY MUST SUBMIT ALL PROJECT ENTRIES IN A SINGLE SUBMISSION ENVELOPE. INCOMPLETE SUBMISSIONS WILL BE DISQUALIFIED. SEE SUBMISSION CHECKLIST FOR ENTRY REQUIREMENTS.
- TO ENSURE FAIRNESS, SUBMISSION MATERIALS <u>WITHIN</u> ENVELOPE AND ELECTRONIC PROJECT SUBMISSION MATERIALS ARE TO BE FREE AND CLEAR OF ANY FIRM OR DESIGNER IDENTIFYING INFORMATION. FAILURE TO COMPLY WILL RESULT IN A DISQUALIFICATION.

CATEGORIES FOR ENTRY

TO RECOGNIZE THE SKILL, TECHNICAL KNOWLEDGE, CREATIVITY AND INNOVATION OF THE ALASKA CHAPTER OF ASID MEMBERS WHO INSPIRE THEIR FELLOW MEMBERS, PEERS AND CLIENTS.

> - **COMMERCIAL/CONTRACT DESIGN:** ALL SECTORS SUCH AS; CORPORATE, INSTITUTIONAL, HOSPITALITY, RETAIL, HEALTHCARE, EDUCATION, CIVIC, MULTI-FAMILY HOUSING & GOVERNMENT.

- **RESIDENTIAL DESIGN:** KITCHEN, BATH, RESIDENTIAL LIVING SPACE, OUTDOOR LIVING SPACE AND UNIVERSAL DESIGN.

SUBMISSION CHECKLIST YOU MUST PROVIDE THE FOLLOWING ITEMS

- ENTRY ENVELOPE: WITH COMPLETED ENTRY FORM ON FRONT AND WET

ALL OTHER MATERIALS TO BE FREE AND CLEAR OF ANY IDENTIFYING INFORMATION. FAILURE TO DO SO WILL RESULT IN A DISQUALIFICATION.

- ENTRY CD OR FLASH DRIVE: MUST INCLUDE ALL SUBMISSION MATERIALS IN .PDF OR

.JPG FORMAT. A SINGLE DEVICE MAY BE SUBMITTED CONTAINING MULTIPLE

PROJECTS. EACH ENTRY MUST BE WITHIN A SEPARATE FOLDER ON THE DEVICE.

- LABEL THE CD OR FLASH DRIVE WITH FIRM NAME.
- LABEL ELECTRONIC PROJECT FOLDER AS: CATEGORY_PROJECT TITLE (IE. COMMERCIAL_ABC ACCOUNTING)
- ENTRY FEE: \$100 CHECK PER PROJECT
- DESIGN CRITERIA FORM: COMPLETED, 1,000 WORDS MAXIMUM TYPED, FREE OF ANY GRAPHIC EMBELLISHMENTS.
- FLOOR PLAN(S): WITH FURNISHINGS IF APPLICABLE IN .PDF FORMAT.
- CEILING PLAN(S): .PDF FORMAT
- IMAGE(S): UP TO SIX (6) PHOTOGRAPHS, RENDERINGS OR ILLUSTRATIONS.

PROFESSIONAL PHOTOGRAPHS ARE NOT REQUIRED.

- IMAGE FILES MUST BE .JPG FORMAT
- CHECK TO ENSURE YOUR PHOTOS ARE HIGH-RESOLUTION (OVER 300 DPI).
- BEFORE & AFTER SHOTS (1 OF EACH) OF THE SAME SPACE MAY BE COMBINED INTO A SINGLE COMPOSITE .JPG FILE ONLY IF BEFORE & AFTER ARE LABELED.
